<u>Good Practices to Combat Social Exclusion of People</u> with Mental Health Problems

The first phase of the project consists in an analysis of the current situation of social exclusion of people with mental health problems in the involved countries, in access to health and social services, employment, education, training services, transportation, leisure as well as the protection of civil and human rights. To this end, the ten partner organisations involved are currently in the process of contacting various stakeholders such as representatives from the governmental, non-profit/NGO and private sectors. Together with the stakeholders the partner organisations will first, analyse the current situation of social exclusion and, in the next step, identify good practices combating the social exclusion of people with mental health problems based on defined quality criteria.

A European Advisory Committee has moreover been established, consisting of members of European Networks active in various different areas such as mental health, poverty, ageing, disability, homelessness and other social issues. The Committee will help the partner organisations and MHE to identify and evaluate good practices as well as to disseminate information about the project and its outcomes. A first meeting of the European Advisory Committee is planned for May 2006 in Brussels (to be confirmed). The second partners meeting will take place 10-11 March 2006 in Paris.

<u>MHEEN Meeting on "Advances in Mental Health Policy</u> <u>and Economics in Europe" and 2nd meeting of the</u> <u>Mental Health Economics II project – Barcelona</u> (Spain), 16-18 February 2006

A MHEEN II (Mental Health Economics European Network II) meeting on "*Advances in Mental Health Policy and Economics in Europe*" will be held on 16th February morning in Barcelona.

The meeting is organised by the Department of Health of the Catalonian Government with the support of the European Commission and in cooperation with the Sant Joan de Déu Foundation, MHEEN and RIRAG/PSICOST Research Networks.

The event will provide a framework for exchanging views and experiences on the recent steps ahead in the field of the mental health and the economic impact of mental health policies in Europe. Key representatives from the Catalan Council of Mental Health and from the Spanish Commission of Mental Health Officers will take part in this meeting.

Ms Marina Geli i Fàbrega, Health Minister of Catalunya, will deliver the opening speech for the second partners meeting of the Mental Health Economics II project (MHEEN II). The event will take place in Barcelona from 16th to 18th February.

MHE Committee on Human Rights

The committee was established in the framework of the EU Co-ordination Non Discrimination Programme, and had a first meeting in November 2004.

It is aimed at reacting on various documents related to human rights issues concerning people with mental health problems, plus formulating position papers on certain matters that MHE wishes to bring to the attention of policy makers and other bodies. The committee held its last meeting on 25 November 2005. Committee members' worked on different topics, such as the follow-up of the Council of Europe Recommendation on the protection of the human rights and dignity of persons with mental disorder, the implications of the likely introduction of compulsory care in the community, and the allocation of personal budget in the EU Member States.

MHE will try to find funding to set up a permanent secretariat for this committee.

Next meeting of the Human Rights committee is planned for May-June 2006.

Report on the CHES Roundtable on the Commission Green Paper on Mental Health

A Roundtable, organised in partnership by the Centre of Health and Ethics in Society (CHES) and Mental Health Europe (MHE-SME), was held on 23 November 2005 to address the recent publication of the Commission Green Paper on Mental Health

The Roundtable offered a genuine opportunity for stakeholders in mental health matters across the European Union (EU) to make their voices heard and to come forward with concrete suggestions for priority actions, thereby ensuring that it will make a concrete and positive contribution towards the development and implementation of an effective EU strategy on mental health.

The aims of the Roundtable were threefold:

- to be informed of the content of the Commission Green Paper and the consultation process
- to analyse and comment on the scope and planned activities of this initiative
- to exchange views and ideas in relation to the themes, priorities and actions of a future EU mental health strategy.

<u>1st Thematic Meeting in the framework of the consultation procedure on the Green Paper on Mental Health – Luxembourg, 16-17 January 2006</u>

MHE was invited by the European Commission, Directorate General Health and Consumer Protection (DG Sanco), to attend the first thematic meeting which was held as part of the consultation. This meeting addressed the theme of "*Prevention and Promotion in Mental Health*".

John Henderson, MHE Senior Policy Adviser, addressed the audience at the opening session about "*Promotion and prevention: a responsibility for society*".

MHE (John Henderson and Mary Van Dievel) participated in the working sessions of the "*EU Platform on Mental Health*", chaired by Clive Needle, together with the European Network of (ex) Users and Survivors of Psychiatry, EUFAMI, and a wide variety of stakeholders: workplace health promotion, doctors, age platform, migrants, education, health platforms, pharmaceutical industry ...

As many other stakeholders could not be present at the Luxembourg meeting, Mr Needle decided to invite them to a second meeting in Brussels early March to further discuss the issue of Prevention and Promotion in mental health and to present a full report to the European Commission afterwards. A first summary of the discussions of the January meeting is available from the MHE secretariat upon request.

A second thematic meeting will take place in Vienna on 16-17 March 2006. The theme will be Social Inclusion and Human Rights.

MHE representation at various meetings

Celebration of World Mental Health Day in Finland

In Finland this year (2005) Mental Health Day was celebrated in conjunction with the Zero-tolerance campaign, which included important mental health organisations.

The main event was organised centrally in Helsinki as an open event, where residents of the Helsinki area were invited to come and enjoy themselves. Along with music and singing, visitors were also offered information about the organisations' activities.

Moreover, the national media were challenged to take part in a public discussion about abolishing the stigmatisation and discrimination aimed at mental health consumers, rehabilitators and families, and the message was carried by dozens of magazine and newspaper articles, as well as radio and TV spots.

Local mental health associations organised their own events throughout Finland.

This year the Finnish Association for Mental Health chose to give a mental health award to Professor of Education, Kari Uusitalo of the University of Helsinki, who has taken a bold public stance in support of Finnish comprehensive schools as the facilitator of equal learning opportunities throughout Finland. He has repeatedly expressed concern about supporting not only gifted students, but also those who lack selfesteem.

In November the Finnish Association for Mental Health received an award from the communication association Yhteiskunnallisen viestinnän yhdistys for the mental health day campaign of 2004, in which *Helsingin Sanomat*, the largest newspaper in Finland, was the co-operation partner.

European Anti-Poverty Network

<u>New framework for the OMC on Social Protection and</u> <u>Social Inclusion</u>

On the eve of the Informal Meeting of the Employment and Social Affairs Ministers, on 19-20 January in Villach (Austria) the European Anti-Poverty Network (EAPN) reacted to the Commission's proposals for a new framework for the Open Method of Coordination (OMC) on Social Protection and Social Inclusion.

On 22 December 2005, the European Commission adopted a Communication entitled "Working together, Working better", which sets out the Commission's proposals to create from Autumn 2006 a streamlined framework for further development of the OMC on Social Protection and Social Inclusion. According to Fintan Farrell, Director of EAPN, "at a time when large sections of the population believe that the over emphasis on the internal market regulations and competitiveness are undermining social protection systems, the Communication must be judged against its ability to address these concerns and to restore confidence in the EU project amongst the citizens".

Mental Disability Advocacy Centre

Russian Appeal Court Declares State's Denial to Provide Services to Children with Disabilities Unlawful

In December 2005, the Supreme Court of the Republic of Karelia (north west Russia) acting as a court of supervisory review, agreeing with legal arguments by the Mental Disability Advocacy Center, found that the Russian government is obliged to provide children with disabilities access to specialized preschool education.

The case concerned three families who had children with complex disabilities including cerebral palsy and intellectual disabilities.

In November 2005 the Supreme Court held in its judgment that in order to ensure social integration of children with disabilities, the Russian law "On education" must be interpreted to impose positive obligations on the State to provide access to specialized educational facilities. The court further held that the law "On Social Protection of People with Disabilities" explicitly stipulates that the State must establish specialized preschool facilities for disabled children who cannot attend general schools.

Thousands of children across Russia are still labeled as "uneducable" and sent to custodial institutions which disregard a child's fundamental right to education. MDAC continues to work on social reintegration issues and in January 2006 will begin a two-year project with the NGO "*Citizens Watch*" to combat social exclusion of people with mental disabilities in St. Petersburg.

Social Platform invited to the Troika meeting on 19 January

The Social Platform received an invitation to participate in the Troika meeting preceding the Informal Council meeting of Employment and Social Policy Ministers in Villach, Austria, on 19 January. This meeting gathered Ministers from the three Troika countries (Austria, Finland, Germany), plus representation from the European Commission and Parliament. The Social Platform was invited to discuss the two themes of the meeting: flexicurity and the streamlining of social protection and social inclusion processes.

The presidency prepared two background papers, on which Platform members have already given comments, and a draft position paper was prepared in advance to an open meeting that took place on 16 January at the Social Platform to discuss the presidency paper and to finalise the Platform contribution. On 18 January, a written contribution was sent to Employment and Social Ministers, European Commission and European Parliament, in advance of the meeting.

<u>WHO's report, "Changing the face of violence</u> <u>prevention"</u>

The World Health Organization's report, "*Changing the face of violence prevention"*, was launched on 19 October 2005 during the 2nd Meeting of Milestones in a Global Campaign on Violence Prevention in San Francisco, United States of America.

The meeting aimed at describing country level achievements in the implementation of the recommendations of the *"World report on violence and health"* and planning next steps.

The reports clearly showed the catalytic effect of the *"World report on violence and health"* on national violence prevention activities including the development of national policies, data collection, improvement of services for victims, primary prevention, and advocacy. Decisions were made on how to further develop the Violence Prevention Alliance, and a special workshop involving representatives from global and national media agencies and public health programmers addressed the feasibility of establishing a global media initiative for violence prevention.

The meeting concluded with a summary of the day's proceedings and thoughts on the way ahead.

<u>Ombudsman pursues inquiry into action taken by</u> <u>Commission to integrate people with disabilities</u>

The European Ombudsman, P. Nikiforos Diamandouros, has called for more information from the European Commission regarding the actions it has taken to ensure the integration of people with disabilities. This follows the extensive response from members of the public, non-governmental organisations and national ombudsmen to the Ombudsman's own-initiative inquiry into the issue. The Commission should submit a report to the Ombudsman by 31 January 2006, on its actions in areas such as employment, accessibility of its premises and information policies.

In its response to the inquiry, the Commission stressed the high priority it attached to promoting equal opportunities for people with disabilities. It listed a number of initiatives it had taken in recent years, including the revision of the Code of Good Practice for the Employment of People with Disabilities.

The Ombudsman then invited comments from the public and received a total of 56 contributions. The concerns expressed in the replies are now taken up in the follow-up questions to the Commission.

Landmark regulation on the rights of disabled air passengers'

In December 2005 the European Parliament unanimously adopted a landmark regulation, which will radically change the lives of the millions of disabled air passengers who have been facing discrimination and humiliation for countless years.

The new initiative, in line with the common rules on compensation and assistance to passengers and recently published European blacklist of unsafe airlines, aims to reinforce the rights of persons with reduced mobility and disabled persons. VIII. EUROPEAN COMMISSION

"Unlocking Europe's full potential": the European Commission's work programme for 2006

In October 2005, the European Commission adopted its Work Programme for 2006, setting out its key priorities for the next year. The Commission Legislative and Work Programme for 2006 takes full account of current economic and political trends and where Europe stands on several key strategic dossiers.

Jose Manuel Barroso commented: "This Work Programme allows Europe to pursue competitiveness and social justice, to protect its citizens and promote their freedoms, to work inside Europe and to promote its values in the world beyond."

The 2006 Work Programme focuses on the key strategic objectives which the Commission has set out at the start of its mandate: prosperity, solidarity, security and Europe as a world partner.

Social justice, cohesion and safeguarding the quality of life for future generations are the goals of the second major objective (solidarity). Initiatives will be taken to tackle the ageing of Europe's population, as well as to streamline the open method of coordination in the social area and launch cooperation on health and longterm care, "*in order to reinforce the support the EU provides to Member States in their efforts to modernize social protection systems and tackle social exclusion"*.

A mid-term review of the Work Programme in summer 2006 will allow the Commission to take stock and, where appropriate, to amend the priority list.

<u>7th Framework Programme</u>

The European Commission has set out the details of its proposal for a new Programme to fund research and development from 2007 to 2013. The Specific Programmes proposed by the Commission put into effect the broad outline proposed by the Commission in April 2005, known as the Seventh Framework Programme, composed of 4 main elements: Cooperation, Ideas, People and Capacities. These will be discussed with the European Parliament (first reading is planned for March 2006), before being decided by the Council.

"What is important now is to allocate sufficient funds to allow this project to achieve its objective of greater competitiveness for Europe and a better quality of life for its citizens", said Janez Potočnik, European Commissioner for Science and Research.

The four major Specific Programmes proposed today are:

- <u>Co-operation</u>: the Cooperation Programme is designed to gain leadership in key scientific and technological areas by supporting cooperation between universities, industry, research centres and public authorities across the European Union as well as the rest of the world;
- <u>Ideas</u>: the Ideas Programme will establish a European Research Council, a pan-European mechanism to support the truly creative scientists, engineers and scholars;
- <u>People</u>: the People Programme looks to strengthen the human resources available to science and research across Europe, both qualitatively and quantitatively;
- <u>Capacities</u>: the Capacities Specific Programme will enhance research and innovation capacity throughout Europe.

Later in the year the European Commission will make a proposal relating to the Rules of participation in the various Specific Programmes. These proposals will be important in terms of the Commission's simplification efforts, aimed at making the Programme more accessible and straightforward for its users.

New measures to help the "active inclusion" of people with disabilities in the EU

In December 2005 the European Commission announced it will put forward concrete measures designed to improve the lives of disabled people in the European Union during the 2006-2007 period. The Communication's overall aim is to improve the "active inclusion" of disabled people through a range of initiatives and measures, including raising disability awareness among small and medium sized companies, reviewing how the European Social Fund can help support employment, training and equal opportunities for disabled people and promoting the concept of independent living for disabled people. These measures will be outlined at European Day of People with Disabilities conference in Brussels, which will be held under the theme of "living together in society".

The EU Commissioner for Employment, Social Affairs and Equal Opportunities, Vladimir Spidla drew attention to the fact that in 2006, all Member States will be obliged to prohibit discrimination in employment on the grounds of disability - in line with the provisions of Directive 2000/78/EC (establishing a general framework for equal treatment in employment and occupation).

The new Communication places a strong emphasis on "active inclusion" of people with disabilities into society and the economy through independent living. One of the main priorities is raising disabled people's employment and activity rates.

The Communication suggests that the best way for disabled people to enjoy this "active inclusion" is through independent living. The EU approach to independent living is that people with disabilities should have the right to benefit from measures designed to ensure their independence, social and occupational integration and participation in the life of the community.

Calls for proposals will be issued for:

- an EU-level organisation representing and defending Roma, to provide support towards its operating costs: this call will be published during the first quarter of 2006 and represents a re-issue of the call originally issued in 2005;
- awareness-raising activities developed by national authorities: this call will only be addressed to the relevant national authorities (EU Member States, Bulgaria, Romania, Turkey) and will be issued in the first quarter of the year;

Calls for tender will be issued for:

• a study on multiple discrimination;

- a study on socially disadvantaged ethnic minorities;
- a study on developing indicators to measure the extent and impact of discrimination;
- non-discrimination training for NGOs and social partners in EU Member States, Romania, Bulgaria, Turkey and European economic Area (EEA) countries.

IX. COUNCIL OF THE EUROPEAN UNION

<u>Health and social priorities under the Austrian</u> <u>Presidency of the EU</u>

From 1 January to June 2006, Austria will assume the role of Presidency of the Council of the European Union. The Operational Programme of the Council for 2006, jointly drawn up by the Austrian and Finnish Presidencies, sets out the main objectives for this year's work of the Council.

In the field of public health, attention will particularly be paid to:

- developments in healthcare for European citizens, with a special focus on nutrition and physical activity, the Alcohol Strategy Communication, mental health, diabetes and women's health;
- the decision establishing a Programme of Community action in the field of Health and Consumer Protection (2007-2013).

The Council will continue or start working on legislative proposals, such as regulation on medicinal products for paediatric use and revision of the legislation on medical devices and advanced therapies.

Due attention will also be devoted to the activities of the World Health Organization (negotiations on protocols to the WHO Framework Convention on Tobacco Control, enforcement of the new International Health Regulations, particularly the Children's Environmental Health - the Budapest process) and to communicable diseases (HIV/AIDS). In the field of social policy, issues such as health care and long-term care, social inclusion, and pension system, will be addressed.

In Good Health Conference, 8-9 December 2005, Edinburgh (Scotland)

Among other issues the recommendations stressed the importance of trans-national exchange, a theme further explored in the report "*Health and Social Inclusion in the EU: the value of trans-national exchange"*, presented at the conference.

The introduction of competitive mechanisms within healthcare systems is one of the trends followed by the reforms in Europe since the establishment of the Thatcher reform in the United Kingdom and the Dekker project in the Netherlands at the end of the 1980's. With the exception of Austria that does not plan to introduce market dialetics into its social protection systems, Switzerland, the Netherlands and Germany have chosen to focus their recent reforms on the idea of competition between health insurance departments or between those offering cares that until now have been nascent. The study by the Department for Research for Evaluation Studies and Statistics (DREES, France) focuses more particularly on competition as a key trend in the latest reforms launched by the Netherlands, Germany and Switzerland.
