### Mental Health Economics II - first partners meeting

A first partners meeting in the project Mental Health Economics II will be held in London, on 29-30 July 2005. The project is a continuation of the previous project Mental Health Economics I, completed by MHE, in collaboration with 17 country partners and the LSE Health and Social Care, in August 2004.

Supported by the European Commission, DG Health and Consumer Protection, Mental Health Economics II is led by London School of Economics, Health and Social Care.

This 24 month project has a number of complementary and interlinked objectives:

- ❑ The primary overarching aim is to gather and analyse information and knowledge in respect of the economics of mental health to contribute to the promotion and protection of public health across Europe.
- ❑ The proposed work would build upon the work of the existing Mental Health Economics European Network (MHEEN) by deepening the work in the 17 current partner countries, and extend the Network into 14 new countries (the 10 new member states, Bulgaria, Romania, Turkey and Liechtenstein).
- ❑ Links would be further strengthened with groups connected to the EC Mental Health Working Party, such as the International Mental Health Promotion Action Network, and the European Workplace Health Promotion Network, as well as other groups including the mental health economics group at the World Health Organisation.

MHE is in charge with the day-to-day co-ordination of the project and will provide support for partners, monitor activities and take a role in the analysis and synthesis of data collected. MHE will also have a role in generating awareness of the project, linking with other initiatives and support an effective dissemination of project results.

## II. NEWS FROM OUR MEMBERS

### SMES Europa- 9th Seminar, 6-8 October 2005

In the framework of the project "Dignity and Health", SMES Europa will hold its 9th Seminar during 6-8 October in Berlin. The theme is "Access for all to rights and services. A person only exists when his/her voice is heard".

Within this project, partners from 11 European countries had exchanged information about local health, social systems in relation with National Action Plans for Social Inclusion and visited a wide-range of activities, from street-level housing services, to job training for the most vulnerable citizens (mentally ill, homeless people, migrants). They will meet in Berlin in October, to share experiences and information on several specific themes:

1. social and health care- access for all to rights and services;
2. beneficiaries of services: involvement and active participation in the process of integration of excluded people;
3. external evaluation and study for ensured quality and efficiency of programmes and services;
4. social situation and National Actions Plan – increasing poverty in Europe.

## III. NEWS FROM OTHER EUROPEAN NGOS

### Social Platform launches report on EC financial regulations

The European Union's Regulation contains all the rules relating to EU grants, which are made to NGOs. Many social NGOs – both at the European and national level – have long felt that the EU's grant-funding process should be made more efficient, less bureaucratic, and more effective in achieving the EU's aims.

In order to make positive suggestions, the Social Platform (of which MHE is a member), together with the European Policy Centre, with Solidar, Concord and the European Women's Lobby, commissioned a study examining the financial relation, and making detailed proposals that would improve the relationship between NGOs and the European Commission.

This study, entitled "*Striking a Balance: Efficiency, Effectiveness and Accountability*" was launched on 26 April in Brussels.

Mary Van Dievel, MHE Director, was present at the launch.

The 90 pages report by Paul Firth states that "the creative partnership between NGOs and the European Commission is being jeopardised by a rigid application of the regulations which govern the financing of NGO activities. The European Commission has over-emphasised adherence to procedures at the cost of damaging the effectiveness of their programmes, so spending a great deal of money on unnecessary and ineffective bureaucracy. The Commission could have avoided many problems caused by their Financial Regulations had they consulted NGOs. Now that the Regulations are being revised, they are at risk of compounding their mistakes by once again not consulting with NGOs."

#### EDF - Annual General Assembly

The EDF held its Annual General Assembly in Barcelona, on 28-29 May. More than 150 leaders of the European disability movement from 29 countries participated in this meeting.

New Governing bodies were elected: for the category "ordinary members" to which MHE belongs, two people from the mental health field were elected as Board members: Josée van Remoortel (MHE Senior policy Advisor) and Igor Pavel (Chair of CEPEC – Confederation of Employment Initiatives and Social Firms). This is very important for the European mental health movement, since they will ensure that mental health issues are taken into account in all EDF activities and policies.

Future priorities and work of the EDF were determined. The discussions focussed on key issues for the European disability movement such as: the structural funds, the European Action Plan on Equal Opportunities for Disabled People, the United Nations Convention on the rights of disabled people and the European policies in the field of transport and accessibility. The national disability councils from UK and the Netherlands asked special attention for mental health and ethnic minorities in the work programme of EDF.

Mary Van Dievel attended the meeting on behalf of MHE.

ENUSP (the European Network of Users and Survivors of Psychiatry) was represented by Mary Nettle, while Nadine Weyts-Fossion attended the meeting on behalf of EUFAMI (The European Federation of Family Organisations).

#### EDF Project for vulnerable road users

The EDF is participating in a new project called VOICE - Vulnerable road user organisations in co-operation across Europe. The principle aim of this project is to raise awareness of the needs of vulnerable road users among European politicians. Every year more than 50000 people are killed on EU roads, whilst more than three million are injured. The project therefore

addresses EU policy makers and tries to highlight good and bad practices.

#### Inclusion Europe Conference

Inclusion Europe and its member in Czech Republic - SPMP -organised a conference on community-based services for people with intellectual disability in Europe, during 19-21 May in Prague.

Statistics by 10 leading disability campaign bodies ([www.inclusion-europe.org/documents/1471.pdf](http://www.inclusion-europe.org/documents/1471.pdf)) show that over 160 000 people with disabilities in Europe are still housed in large-scale institutions. The plenary and focus groups sessions concentrated on legislative changes needed for funding community-based services, on assessing service needs and quality and on person-centred planning.

We have the right to live as anybody else," said a disabled person from Úpetov in Czech Republic. "(...) To find a place is not easy. There are few possibilities and it costs a lot. Most of us would like to live with our partners or on our own. We would like to show everybody that we are able to look after ourselves as we can do it, we just need the opportunity to prove it." #### MDAC protests against Czech Republic legalize human rights abuse

The senate of the Czech Republic adopted on 5 May an amendment of the law on social care legalising the use of restraints – including cage beds – in Czech social institutions.

The Mental Disability Advocacy Centre (MDAC) together with the League of Human Rights issued a press release protesting against this abuse of human rights. The Czech Association for Mental Health also supported their position.

The press release highlights that over 17 000 Czech adults and children with mental health problems, intellectual disabilities or substance abuse problems currently live in social care. These homes are not medical institutions and none of them have full-time doctors. They are custodial institutions where people often spent their entire life and are subject to the legal use of restraints – cage beds, leather straps as well as sheets and towels.

Article 89a of the new Act purports to regulate restrain use in all social care institutions. However, the law regulates the use of restraints inadequately.

#### Applications for the Roma Diplomacy Programme

The European Roma Information Office and DiploFoundation invite applications for the upcoming Roma Diplomacy Programme, which is due to start in July 2005.

This is a yearlong educational programme for professionals from Eastern European countries working in the field of Roma and human rights, and consists of a combination of workshops and online learning.

The programme aims to:

- Create a strong group of Roma “public diplomats”, with the ability to use the gap between the Roma civil society and governments/EU institutions;
- Create and extend the existing Roma rights networks, to facilitate access to diplomatic channels when they are required;
- Facilitate the sharing of research and experience of Roma and human rights activists with a focus on diplomacy;
- To build practical capacity among Roma rights activists, through participation in conferences and internships in various institutions.

Participants must be currently working in the Roma rights' field, hold an undergraduate University degree or have at least three years relevant work experience, have a sufficient command of English, unrestricted access to Internet and be prepared to attend the 10 day workshop in Bucharest, in July 2005.

Full funding is available for 20-25 participants. Preference for funding will be given to Roma applicants.

#### Letter of protest from civil society against anti-Gypsyism in Romania

In a letter of protest addressed to the Romanian Presidency, several European NGOs strongly condemned the position of the mayor of Craiova (Romania), who used unacceptable insulting words when talking about gypsies (“stinky ugly gypsies”, “shits”, “jerks”, “dirty”, “hooligans”) and who talked openly about a war against gypsies and his wish to deport them out of the city.

His words were quoted in an article published by *Guardianul* (The Guardian), one of the top ten newspapers in Romania, on 4 May 2005.

The protest letter emphasises not only the shocking statements, but also the fact that this has been published in one of the mainstream newspaper in Romania, without any comment about “open anti-Gypsyism and the abysmal situation of Roma in Romania”.

The NGOs signing the letter call on the Romanian government to set up clear measures to combat such attitudes and to make a public statement condemning Craiova mayor's comments.

The letter reminds that several statements of this type were made by various public Romanian personalities in the past and recalls that the Romanian government is still hesitant in addressing the genocide of Roma during the second World War and the over 500 years of slavery of Roma on the Romanian territory.

The NGOs invite Romanian government to present formal apologies and to make a clear gesture of reconciliation.

Moreover, the letter mentions the recent resolution of the European Parliament on the situation of the Roma in the European union recognising the strong European anti-Gypsyism and calls on the European Commission not only to encourage Member States to act against racism, but also to find concrete ways to promote measures to combat anti-Gypsyism in Europe.

The letter was initiated by the European Roma Information Centre and was signed by more than 15

European NGOs (among which Mental Health Europe) and also by a large number of Roma NGOs, mainly from Romania.

## IV. WORLD FEDERATION FOR MENTAL HEALTH

### Participation at the UN Commission on the Status of Women

The WFMH had an active participation at the 49 Session of the Commission on the Status of Women (CSW), which took place at UN Headquarters, in New York, from 28 February to 11 March 2005.

The two-week session was an opportunity for governments to review the progress made since the 1995 World Conference on Women in Beijing. The session was also an important NGO event. More than 2600 non-governmental representatives attended from all regions of the world.

The WFMH UN representatives have been attending the annual sessions of the CSW since 1991, contributing to discussions in regard to women and mental health. At the 2005 session, the WFMH delegates organised two separate panels of experts: The first program, *Promoting Mental Well-Being for Asian Women* discussed best practices in mental health that promote healthy lifestyles. In the second programme, *Mainstreaming Mental Health as Integral Strategy for the Advancement and Empowerment of Women and Girls*, the speakers focused on the promotion of psychosocial well-being and the improvement of mental health as a strategy for addressing a broad range of women's concerns.

WFMH also joined with the International Association of Schools of Social Work to present an open dialogue on the tsunami and the psychosocial needs of women. Speaking about the situation of women following the disaster, panel members noted that sexual violence was widespread and seldom acknowledged by officials. They reported that women wanted to take control of their own lives, to have their expertise recognized, and did not want psychiatric interventions and to be told what to do by outsiders.

The WFMH representatives were also responsible for drafting and coordinating a written statement on women and mental health, submitted as part as the official documentation of the CSW. They also worked on incorporating mental health and psychological response into **two resolutions** adopted by the CSW, one on **Gender issues and the Tsunami Recovery process**, and the other on **Trafficking**.

The most significant outcome of the meetings was a **Declaration** reaffirming the governments' commitment to the Beijing Platform for Action:

## Preparations for the WFMH World Congress

The 2005 WFMH World Congress takes place on 4-8 September 2005 at the Grand Hyatt Hotel, Cairo, Egypt. This year's theme of the congress, chaired by the former WFMH President Ahmed El Azayem, is Equity and Mental Health.

Highlights of the programme include lectures by Professor N. Sartorius, who will speak on the continuing impact of stigma and discrimination as a barrier to improving the global climate for mental health services, promotion and prevention.

As the secretary of the Iraqi Society of Psychiatrists, Numan S. Ali will address the mental health implications of war, trauma and conflict in Iraq.

Beverly Long is going to draw attention to the international need for measures to include scientifically-based prevention in public health. Ahmed Gamal Abou El Azayem will outline his conclusions in the prevention and treatment of substance dependence.

Special symposia on consumer/caregiver issues, will pay due recognition to consumer and caregiver involvement in treatment and continuing care.

An additional special symposium will be organised by Emeritus Professor B. Robertson on the mental health consequences of HIV/AIDS. The Member Assembly will be held on Wednesday, 7 September. The slate of Officers and Directors for 2005-2007 Board of Directors will be presented on this occasion.

## **V. WORLD HEALTH ORGANIZATION**

### Follow-up meeting of the WHO European Ministerial Conference on Mental Health

The meeting took place in Copenhagen, on 12 May 2005 and was the first follow-up meeting of the Helsinki conference of last January.

The meeting was attended by Mental Health Europe, EUFAMI, the European Network of (ex-)Users and Survivors of Psychiatry, Global Initiative for Psychiatry, the Hamlet Trust, the Mental Disability Advocacy Centre, the Open Society Mental Health Initiative and the Mental Health Foundation, all European-wide networks except for the Mental Health Foundation.

Matt Muijen, WHO Regional Adviser for Mental Health, expressed his gratitude for the support he received from the NGOs in the preparation of the Helsinki conference and at the conference itself. He said it was a real opportunity for interaction between the governmental and the non-governmental level.

Matt Muijen presented the 7 development areas selected for the implementation the WHO/Euro Action Plan on Mental Health:

- 1) Stigma and discrimination
- 2) Mental Health Promotion
- 3) Prevention and Suicide
- 4) Service development
- 5) Workforce
- 6) Information and dissemination
- 7) Empowerment

For the 6 first areas, WHO has already selected an organisation that would develop the topic. These

organisations should not work on their own, but should set up a Network and make sure they are backed by their government.

For the 7<sup>th</sup> area – empowerment – WHO wanted to discuss with the NGOs present how to proceed. It was agreed that the Mental Health Foundation (UK) would for maximum 1 year offer part time resources to further develop this issue, in collaboration with the organisations present at the meeting.

Hedinn Unnsteinsson, "Civil Society Officer" at WHO/Euro presented the ICS (Inclusion of Civil Society) project for which he could obtain a grant from an Icelandic charity. He will set up a pilot project on the inclusion of civil society in 3-4 countries, to show how people with mental health problems, their families and carers, professionals and governments can work together to further the interests of people with mental health problems.

Hedinn Unnsteinsson will also be closely involved in the work of the group that will develop the empowerment issue.

### World Health Report 2005: Let every mother and child count

The report focuses on those developing countries where progress in maternal and child health is slow, stagnating or has even gone into reverse in recent years. It says that the resulting death toll could be sharply reduced through wider use of key interventions and a "continuum of care" approach for mother and child, that begins before pregnancy and extends through childbirth and into the baby's childhood.

According to the report, mental ill-health in pregnancy appears to be more common than previously recognized. Although pregnancy has been regarded as a period of general psychological well-being for women, high rates of psychiatric morbidity in pregnant women have been reported. Pre-existing psychological disturbances can easily surface as depression, substance abuse or attempts at suicide, particularly when combined with pregnancy that is unwanted.

At a time when only a decade is left to achieve the Millennium Development Goals (MDG) the report serves as a reminder that these goals underline the importance of improving health. Especially the health of mothers and children, as it is an integral part of poverty reduction.

### Public hearings on women and health

The European Parliament Women's Rights Committee hold a public hearing on women and health, which is currently the subject of a report prepared by the vice-president of the Committee, Eva-Britt Stevansson (Sweden). The link between women's health and their socio-economic situation and psychological condition was emphasised. Cancer, alcoholism, smoking, drugs,

bad health, depression, suicidal tendencies are some of the examples that illustrate the inequality between men and women in terms of public health.

## VII. EUROPEAN COMMISSION

### EC Working Party On Mental Health

The third meeting of the Working Party on Mental Health took place in Luxembourg on 30-31 May 2005.

An update was made on membership and observer status in the Working Party, as well as on recent policy developments regarding the Strategy on Health and Consumer Protection (2007-2013). The Green Paper on Mental Health, the Council Conclusions on Mental health Action Plan and preparations for the Work Plan 2006 were also considered.

Group discussions explored the following topics:

1. how to ensure policy-relevance of mental health projects supported by the Public Health Programme;
2. what measures are needed to improve dissemination of projects results?
3. How to ensure sustainability of project achievements after the end of the project?

Short presentations were given on projects recently completed or on new projects supported by DG SANCO:

- Health Indicators for People with Intellectual Disability;
- Placement and Treatment of Mentally Ill Offenders – Legislation and Practice in EU Member States;
- The Status of Mental Health in the European Union;
- European Policy Information Research For Mental Disorders;
- European Platform for Mental Health Promotion and Mental Disorder Prevention: Indicators, Interventions and policies;
- Monitoring Suicidal Behaviour in Europe;
- Mental Health Economics II.

MHE was represented by John Henderson (Deputy Chair of the Group) et par Colette Verspoten (MHE treasurer) who was invited as observer.

This text is a follow-up to the adoption of the European Youth Pact by the European Council in March 2005, which made young people a key part of the renewed Lisbon partnership for growth and jobs and which proposed taking action for young people in the fields of employment, integration and social advancement, education and training, mobility, and reconciling family and work life.

The Communication sets out how the Pact can be put into operation, defines the priorities of the Youth Open Method of Coordination, addresses a youth dimension in other policies, lists relevant European programmes and examines how to further involve young people in the political process.

The Council of Europe's Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment (CPT) published the report on its visit to Latvia in September/October 2002, together with the Latvian Government's response. These documents have been made public with the agreement of the Latvian authorities.

During this visit, the CPT's delegation reviewed the measures taken by the Latvian authorities following the recommendations made by the Committee after the 1999 visit. Particular attention was paid to the treatment of persons detained by the police and border guards, as well as the conditions of detention of life-sentenced prisoners and of juveniles on remand held in prison. For the first time in Latvia, a visit was carried out to a social welfare home.

## XI. PUBLICATIONS/WEBSITES

### Report on Health-related Stigma and Discrimination

The report is the result of a workshop on Research on Health-related Stigma and Discrimination organised by the Royal Tropical Institute in Soesterberg, during 29 November – 2 December 2004. More than seventy researchers and experts in the fields of leprosy, HIV/AIDS, tuberculosis, Buruli ulcer, mental health care, epilepsy and physical disability participated in the workshop. Together they represented 55 academic institutes, organisations and health projects in Europe, Africa, Asia, North and South America.

The workshop had three main themes:

- creating a model for health related stigma;
- establishing a methodological approach to measuring health related stigma;
- identifying effective interventions to help diminish health-related stigma.

Stigma is a complex construct, is disease specific, culture-specific and contributes to the 'hidden burden' of disease. Stigma has an impact on the affected person by increasing personal suffering, affecting access to health care, and often also affecting human rights.

The message of the report is that, by pooling research findings and experiences, it would be possible to find commonalities in stigma theories, measurements and interventions and identify disease, culture and situation-specific features.

The report highlights that social structures are an integral to a study of stigma: those who are stigmatised are in part exploited, and in part oppressed. Therefore, stigma can be reduced by three different types of change:

- operational - can be achieved by health professionals within the health care system;
- political - requires action by governments;
- and structural - involves shifts at the level of social structures like relations of class, command, gender, ethnicity and age.

However, although it is in the interest of public health to work to reduce stigma, a conceptual tension may exist between public health management of disease and stigma reduction (for example, exclusionary measures can be experienced as stigmatising, but are often based on rational public health control strategies).

The report also argues that the concept of stigma has been overstretched, and, because of that, is at risk of becoming meaningless. Therefore, it is important to identify the domains of stigma relevant to health and to clarify that stigma is a process, not a thing.

A major finding of the workshop was that social and societal consequences of stigma and discrimination are very similar across the different healthcare disciplines, as well as across different countries and cultures.

The report proposes a list of potential indicators of stigma (indicators for institutional discrimination, for interpersonal discrimination, for policy, political and legal discrimination, and some potential interventions).

### Study on substitution treatment in European prisons

On behalf of the Cranstoun drug services the researchers L. Hennebel, H. Stover, J. Casselman and E. Spacca carried out a study on policies and practices of substitution treatment in prisons of 18 European countries. The study covers obstacles to the introduction of substitution treatment and explores limitations that prisoners encounter, when attempting to access these services. Prison systems were found to be slow in responding to epidemics of viral infectious diseases such as HIV and Hepatitis, as well as injection drug use. Substitution treatment was often seen as a response to the dangers encountered by opiate dependent inmates. The research suggests that offenders participating in substitution treatment display increased productivity and lower readmission rates overall. Yet, the studies indicate that continuity of care is required to maintain any benefits acquired. Further substantial efforts need to be made, to improve the quality of these services. And the links and continuity of care between prisons and the range of community based services need to be improved. The study is available at [www.endipp.net](http://www.endipp.net).
